1. Why are you seeking the position of Judge of the Court of Common Pleas?

I want to put my work and life experiences to use serving the citizens of Erie County. All individuals should have equal access to the legal system and should be treated with dignity and respect in the courtroom, regardless of economic, social or political status. I have the integrity, temperament, knowledge, experience and patience to perform the duties and handle the responsibilities required of the position. I am ready to hear the same type of cases heard by the Honorable Judge Elizabeth K. Kelly during her tenure on the bench.

Explain how your practice has prepared you for the position of Judge of the Court of Common Pleas.

Over the past 30 years, my law practice has concentrated on family law, estate planning and administration, elder law and real estate. In the area of family law, my practice has focused on matters involving child custody, child support, spousal support, alimony, divorce, prenuptial agreements, marital settlement agreements, adoptions and Protection From Abuse Orders. I am also collaboratively trained in family law matters.

Since the beginning of 2024, I have served, and continue to serve, as First Assistant County Solicitor for Erie County. In this position, I have gained experience and knowledge in the area of prisoner litigation and various civil matters on behalf of the County.

I have made many significant achievements in my 30 years of practicing law. I have successfully litigated and received numerous favorable rulings in complex matters, including family law, estates and civil litigation. I have received favorable results from the Pennsylvania Department of Revenue regarding estates and inheritance tax. I have also conducted hundreds, if not thousands, of real estate transactions, both residential and commercial.
